NOTICE is given that Cambridgeshire County Council has made an Order pursuant to the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the effect of which is to stop any vehicle from proceeding along High Street, West Wickham as lies between numbers 39 and 59.

Access will be maintained to properties affected by this order.

The alternative route for vehicles is via High Street Southern Spur - Balsham Road - Mill Road - Mill Road, West Wratting - The Common - Burton End - Burton End, West Wickham and vice versa.

The Order is made to facilitate sewer connection and vehicle access construction works which are being carried out on or near this highway and it will come into operation on 22 July 2019 and continue until these works have finished or on the 21 January 2021 whichever is the earlier.

It is anticipated that these works will be carried out 08:00hrs to17:00hrs daily between 22 July and 26 July 2019.

The Order shall not apply to any persons lawfully engaged in connection with any works for which it is made, any member of the Police Force, Fire and Rescue Service, Ambulance Service, a vehicle being used by Special Forces during the execution of their duties or to any person acting with the permission or upon the direction of a Police Officer in uniform.
